LOCAL Law No1 – CLEAN WATER, WORKING FARMS, WILDLIFE HABITAT, RECREATION AND NATURAL AREAS PRESERVATION FUND

Shall Local Law No. 1 of 2022 ENTITLED "A LOCAL LAW TO PROTECT THE WATER QUALITY OF RIVERS, LAKES, AND STREAMS, INCLUDING THE WALKKILL RIVER; PROTECT THE WATER QUALITY OF GARDINER'S DRINKING WATER; PRESERVE WORKING FARMS, ESTABLISH PARKS AND RECREATIONAL AREAS; AND PROTECT HISTORIC RESOURCES AND NATUARAL AREAS BY CREATING A ONE AND ONE QUARTER PERCENT REAL ESTATE TRANSFER TAX ON THE CONVEYANCE OF INTERESTS IN REAL PROPERTY IN THE TOWN, WITH REVENUES FROM THIS TAX TO BE DEPOSITED IN THE TOWN OF GARDINER COMMUNITY PRESERVATION FUND, WHICH MAY BE MATCHED BY STATE AND FEDERAL FUNDING AND WHICH WILL REQUIRE FULL PUBLIC DISCLOSURE OF ALL SPENDING" be approved?
