

RESOLUTION ADOPTING LOCAL LAW NO. 1-2023

At a special meeting of the Town Board of the Town of Hardenburgh, held at Hardenburgh Town Hall, 51 Rider Hollow Rad, Arkville New York on the 4th day of August 2023, the following resolution was offered and seconded as follows:

WHEREAS, the Town Board of the Town of Hardenburgh at its regular meeting held on July 13, 2023, introduced proposed Local Law No. 1 of the Year 2023, entitled, "A LOCAL LAW ABOLISHING THE ELECTED POSITION OF TOWN HIGHWAY SUPERINTENDENT AND ESTABLISHING AN APPOINTED TOWN HIGHWAY SUPERINTENDENT POSITION"; and

WHEREAS, the Town Board gave notice that a public hearing will be held regarding said proposed Local Law on August 4, 2023 at 6:00 p.m. at the Town Hall; and

WHEREAS, said public hearing was duly noticed and held on the 4th day of August, 2023 at 6:00 p.m., at which all parties in attendance were permitted an opportunity to speak in support of or in opposition to said proposed Local Law, or any part thereof; and

WHEREAS, the adoption of this proposed Local Law constitutes a Type II action Under the State Environmental Quality Review Act (SEQRA) and its implementing regulations and, thus, no formal environmental review of this action is required; and

WHEREAS, the Town Board of the Town of Hardenburgh, after due deliberation, finds it in the best interest of the Town to adopt said local law.

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Hardenburgh hereby adopts Proposed Local Law No. 1 of the Year 2023 as Local Law No. 1 of the Year 2023 entitled "A LOCAL LAW ABOLISHING THE ELECTED POSITION OF TOWN HIGHWAY SUPERINTENDENT AND ESTABLISHING AN APPOINTED TOWN HIGHWAY SUPERINTENDENT POSITION"; and

BE IT FURTHER RESOLVED the Town Clerk be and hereby is directed to enter said Local Law in the minutes of this meeting and to give due notice of the adoption of said Local Law to the Secretary of State, subject to the outcome of the mandatory referendum on the same; and

BE IT FURTHER RESOLVED that this resolution will take effect immediately upon filing with the Department of State, subject to mandatory referendum.
