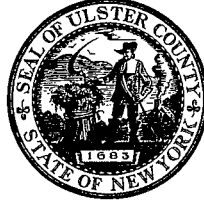

ABSTRACT OF PROPOSED LOCAL LAW NO. 17 OF 2023 OF THE COUNTY OF ULSTER, A LOCAL LAW AMENDING THE ULSTER COUNTY CHARTER, (LOCAL LAW NO. 2 OF 2006), AND AMENDING THE ADMINISTRATIVE CODE FOR THE COUNTY OF ULSTER, (LOCAL LAW NO. 10 OF 2008), TO MODIFY VARIOUS PROVISIONS

The following represents a brief abstract of the above referenced charter law which is the subject of a proposition to be voted upon by the electorate of Ulster County on November 5, 2024. Proposed Local Law No. 17 of 2023, in summary:

This law would amend various provisions of the Ulster County Charter, recommended by the Ulster County Charter Revision Commission and approved by the Ulster County Legislature, including, but not limited to, Legislative confirmation of the Director of Real Property Tax Service, County Attorney, Director of Weights and Measures, and Director of the Department of the Environment, establish residency requirements for the office of Ulster County Comptroller, require Legislative approval of the Ulster County Comptroller's order of succession, designate the Ulster County Clerk as the appointing authority of the County Historian, and include the Department of Environment as part of the Ulster County Charter.
