ABSTRACT OF PROPOSED LOCAL LAW NO. 9 OF 2023 OF THE COUNTY OF ULSTER, A LOCAL LAW AMENDING THE ULSTER COUNTY CHARTER, (LOCAL LAW NO. 2 OF 2006), AND AMENDING THE ADMINISTRATIVE CODE FOR THE COUNTY OF ULSTER, (LOCAL LAW NO. 10 OF 2008), TO AMEND ARTICLE II LEGISLATIVE BRANCH §C-21 FILLING MEMBERSHIP VACANCIES

The following represents a brief abstract of the above referenced charter law which is the subject of a proposition to be voted upon by the electorate of Ulster County on November 5, 2024. Proposed Local Law No. 9 of 2023, in summary:

This law would require public advertisement of a vacancy in the Ulster County Legislature occurring outside of a regularly scheduled election, require a majority vote of the Town/Village Board(s) and or City of Kingston Common Council within the effected Ulster County Legislative District, and clarifies if/when the vacancy is to be filled at a special or general election.
