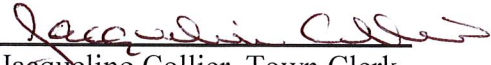

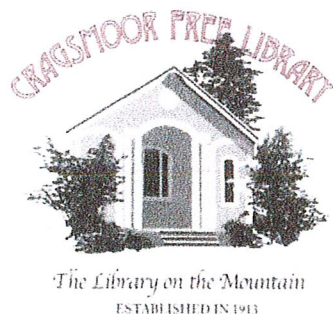

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE CRAGSMOOR FREE LIBRARY

A meeting of the Board of Trustees of the CRAGSMOOR FREE LIBRARY was held at 10:00 a.m. on the 14th day of June, 2026.

The following Trustees were present, constituting a quorum of the Board:

Mirella Affron, Charles Affron, Donna Christie, Mary McAlpin,
Carolyn Penrose, Bernhard Roze and Nancy Shapiro.

The following motion was made, seconded and unanimously carried:

WHEREAS, there has been presented to the Board of Trustees of the Cragmoor Free Library a petition signed by qualified voters of the Town of Wawarsing in a number exceeding the twenty-five (25) required, asking that the following question be placed upon the ballot and voted on at the next general election of the Town of Wawarsing:

**SHALL THE ANNUAL CONTRIBUTION OF THE TOWN OF
WAWARSING FOR THE OPERATING BUDGET OF THE
CRAGSMOOR FREE LIBRARY BE ESTABLISHED IN THE
AMOUNT OF NINETY-NINE THOUSAND DOLLARS (\$99,000)
ANNUALLY?**

WHEREAS, the endorsement of this Board of Trustees of the Cragsmoor Free Library is required before such question may be placed upon the ballot,

NOW, THEREFORE BE IT RESOLVED, that this Board of Trustees hereby endorses the petition presented to it and directs the following question to be voted on at the next general election of the Town of Wawarsing:

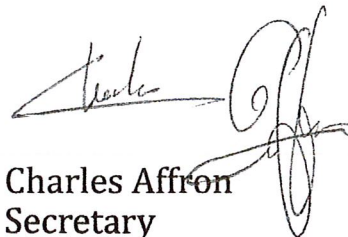
